

Privacy Policy

South Street Advisors, LLC (“SSA”) has implemented the following privacy policies and procedures to protect the security of your personal data and non-public confidential information. This Privacy Policy explains the kinds of personal data SSA collects and processes, our reasons and purposes for collecting the data, how the data will be processed and by whom, and your rights with regard to your personal data.

Personal Data We Collect and Process

We collect your personal data any time you visit our website, request that we contact you, sign up for our content, or provide personal information to us in order to receive our services. We collect, among other things, information relating to your first and last name, your email address, your organization name, your country of residence, and your title (when appropriate). From time to time we may also collect personal data through the use of survey forms, contact forms, or when you request copies of our research documents and whitepapers or download content from our website. We collect and process your personal data in connection with your on-going relationship to SSA such as through correspondence, telephone calls, or other forms of contact.

We also collect data we receive automatically from your web browser or mobile devices, which may include the name of the website from which you entered our website, if any, as well as the name of the website you visit when you leave our site. This information may include the internet protocol (“IP”) address of your computer or proxy server that you use to access the internet, your internet provider name, your web browser type, the make and model of your computer or mobile device, and your operating system. We may monitor your activity on our website for any lawful purpose; however, you may visit our website anonymously.

Our Reasons for Collecting Your Data

Your personal data is collected so that we may provide you with the information you request. The information and data we collect may be used, without limitation, in any one or more of the following ways, including:

- Processing of contact and content subscription requests

- Improving user experiences with our website and online content
- Improving customer service and support
- Monitoring the use and visits to our website
- Conducting statistical analysis and market research
- Response to and evaluation of questions and/or complaints
- Maintaining appropriate business records
- Establishing, exercising, or defending against legal claims
- Establishing and ensuring our compliance with data protection regulations and laws
- Communicating with you through our direct marketing activities
- Improving and maintaining our website, products, and services

Your personal data – whether public or private – will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever without your consent except as stated below or unless sharing your personal data is necessary to deliver a product or service you have requested from us. We reserve the right to collect and use any non-personal data made available to us by your use of our website. We further reserve the right to aggregate such data for our internal analytics, which help us improve our website and service, and we may share – or sell – our data aggregations with and to others. At no time is your personally identifiable data included in such data aggregations.

Who May Access Your Data

From time to time, we may disclose your personal data to recipients in connection with the purposes stated above, including:

- SSA personnel;
- Third parties who we engage to provide services to us, such as information technology service providers, which may collect and process your personal data confidentially on our behalf;
- Third-party financial institutions and licensors of our services; and/or
- Auditors, or other regulatory authorities as requested or required by law.

Whenever we engage third parties to provide services that may involve the collection or processing of your personal data, we require that they agree to abide by the terms of our privacy policy and comply with all applicable laws and regulations regarding the use of personal data.

Cookies and Re-Targeting Tools

Our website uses “cookies” to identify the areas of our website that you have visited. A cookie is a small piece of data stored on your computer or mobile device by your web browser that allows us to recognize your browser and collect and remember information. We use cookies to personalize the content that you see on our website and to compile aggregate data about site traffic and site

interaction so that we can improve our website and provide you with a better online experience.

Your Rights

We collect your data in order to provide you with our services, but also to improve the service we provide. Your help in this regard is appreciated, and we continually work to protect your data privacy rights, including, among other things, the following:

- **Lawfulness, fairness, and transparency:** we only collect and process personal data in a manner that is lawful, fair, and transparent to you.
- **Purpose limitation:** we only collect personal data for the reasons and in the ways stated above, and we do not process personal data in any way that is incompatible or at odds with those purposes.
- **Minimization:** we only collect personal data that is adequate, relevant and limited to what is necessary to achieve our stated purposes.
- **Accuracy:** we attempt to keep your personal data accurate and up to date, and from time to time we may request that you confirm the accuracy of your data.
- **Storage limitation:** we keep your data no longer than is necessary to achieve the stated purposes and/or long enough continue providing you with the service or information you have requested from us.
- **Integrity and confidentiality:** we take reasonable and appropriate steps to ensure the security of your personal data and to protect against unauthorized processing or accidental loss or destruction of your data.
- **Accountability:** we document our activities to show how we protect your data.
- **Portability:** we respect the fact that your data is your data. If you want us transfer your personal data to you or to someone else, contact us and we will work with you to send the data where you want it in the format needed.
- **Right to be forgotten:** if you want us to delete some or all of your information, simply let us know and we will honor your request as quickly as possible.

We will not use your personal data for any reason without your consent.
